Firearm Discharge Review Board Summary



Firearm Discharge Review Board

Since the last presentation to the Police Commission, on April 19, 2017, the Firearm Discharge Review Board has convened three times: June 28th (2nd Quarter 2017), July 31st (3rd Quarter 2017, #1), and September 20 (3rd Quarter 2017, #2).

The FDRB reviewed the following completed investigations:

Officer Involved Discharge 006-16

Date: October 1, 2016
Location: 2500 Block of 41st Avenue

At approximately 02:25 hours, a uniformed officer was attempting to render a firearm safe that had been recovered during an incident, intending to transport the weapon. Under the direction of a sergeant on scene, the officer attempted to de-cock the weapon causing an unintended discharge into the ground. No one was injured as a result of the discharge.

Recommendations: Not In Policy (Officer for negligent handling of weapon);
Not in Policy (Sergeant for failure to properly supervise)

Additional: The officer was retrained in the proper handling of firearms.



Officer Involved Discharge 001-17

Date: March 11, 2017
Location: Post and Kearny Streets

At approximately 11:58 hours, a uniformed officer was directing traffic for the St. Patrick's Day Parade. An off-leash Pitbull charged the officer in response to a command by the owner. The officer retreated, then fired his Department-issued handgun one time, striking the dog in its right front leg. No one else was injured.

Recommendation: In Policy

Additional: The FDRB recommended that a review of the Department's practice not to issue a BWC prior to an officer's probationary assignment, now that BWCs have been fully deployed.



Officer Involved Discharge 002-17

Date: April 25, 2017

Location: Northern Station

At approximately 05:50 hours, a uniformed officer was in the gun cleaning room reloading his firearm when he unintentionally fired the weapon. No one was injured.

Recommendation: Not In Policy

Additional: The FDRB recommended notices be posted at weapons cleaning stations to remind officers of their obligations with respect to the safe loading and clearing of firearms.



Officer Involved Shooting 14-006

Date: October 7, 2014
Location: 400 Block of Bryant Street

At approximately 20:50 hours, uniformed officers used cover and concealment to clandestinely observe three subjects burglarizing a vehicle. As the officers moved in to arrest them, the driver of the suspect's vehicle drew a firearm and pointed it at the first officer closing in. Fearful he was about to be seriously injured or killed, the officer opened fire, striking two of the suspects. The driver was mortally wounded; his accomplice was injured and taken into custody.

Recommendation: In Policy

Additional: The involved officer was found to have violated equipment-related policy. The FDRB recommended an additional finding of Not In Policy pertaining to the identified violation.



Officer Involved Shooting 15-001

Date: January 4, 2015

Location: 400 Block of Mason Street

At approximately 08:54 hours, uniformed officers responded to a nightclub regarding an alarm activation. Finding an open door, officers entered the premises to investigate. During the ensuing search, a subject suddenly broke from cover and an officer fired one time at the subject, fearing an attack was immediate. No one was injured as a result, and the subject was taken into custody.

Recommendation: Not In Policy



Officer Involved Shooting 15-002

Date: January 4, 2015

Location: 630 Valencia Street

At approximately 17:21 hours, three uniformed sergeants assigned to Mission Station were confronted by a man in a restricted area of the station parking lot. The officers directed him to leave, but he refused. The officers attempted to use physical controls and pepper spray, to no avail. The suspect drew a weapon from his waistband, and two of the sergeants fired at the suspect, mortally injuring him.

Recommendation: In Policy



Officer Involved Shooting 15-003

Date: February 26, 2015
Location: 2800 Block of Folsom Street

At approximately 21:44 hours, Mission Station officers responded to a call of a man armed with a knife chasing another man. Two plainclothes officers arrived first and attempted to detain two men matching the broadcast description. One of the subjects slashed at one officer with a large butcher knife, before similarly assaulting the second officer. As the suspect began turning back toward the other subject, the officers fired at him in defense of the themselves, their partner, and the other subject. The suspect was mortally wounded.

Recommendation: In Policy

Additional: One of the involved officers was found to have violated equipment-related policies. The FDRB recommended an additional finding of Not In Policy pertaining to the identified policy violation.

The FDRB also reviewed the adoption of the Everbridge automated notification system for critical incidents.

OIS Investigations Update

The 1st Quarter 2017 OIS Investigations Report was presented to the Police Commission on April 19, 2017. Since that report:

- **Four (4) OIS investigations were presented to FDRB and completed** (OIS 14-006, 15-001, 15-002, and 15-003). These investigations are completed.
- **Three OIS investigation opened** (OIS 17-003, 17-004, and 17-005) on May 3, May 21, and September 24, respectively. Criminal investigations were started by the SFPD Homicide Detail and the Office of the District Attorney's Independent Investigations Bureau. Administrative investigations were started by SFPD Internal Affairs Division and the Department of Police Accountability. Two cases (17-003 and 17-005) also include a Medical Examiner's investigation.
- **Nine summary reports, formally concluding SFPD Homicide Detail investigations, were received by IAD** (OIS 14-005, 14-006, 15-001, 15-002, 15-003, 15-008, 15-010, 16-001, and 16-002). These cases have been presented or will be presented to the FDRB.



Open OIS Cases Summary

As of October 4, 2017, there are **fourteen (14) open SFPD OIS investigations**. Of these fourteen cases:

- **Notices were received from the Office of the District Attorney for two (2) open cases** in September 2017 (14-005 and 16-003).
- **The DA is reviewing or actively investigating twelve(12) open OIS cases** (14-007, 15-004, 15-007, 15-008, 15-009, 15-010, 16-001, 16-002, 17-001, 17-003, 17-004, and 17-005).
- **Approved Homicide Detail summary reports have been received for four (4) open cases** (14-005, 15-010, 16-001, and 16-002). These cases are being prepared for presentation to the FDRB. Special FDRB sessions will convene through 4Q17 regarding completed investigations.
- **Homicide Detail summary reports are being finalized for six (6) open OIS cases** (14-007, 15-004, 15-007, 15-008, 15-009, and 16-003).
- **Four (4) OIS incidents are active criminal investigations** by the SFPD Homicide Detail (17-001, 17-003, 17-004, 17-005).
