Officer Involved Shooting 12-003

Incident: Wednesday, July 18, 2012
Location: 100 block of Washington Street @ Davis Court
Finding: In Policy

At approximately 10:27 AM, uniformed police officers from Central Station responded to a report of a stabbing in the area of Pier 17. A victim was located with slash wounds on his right forearm. Officers located the suspect on Washington Street, approaching Davis Court. The suspect, carrying a bloodied box cutter, ignored the officers verbal commands to stop and to drop his weapon. Officers radioed for less lethal and attempted to contain the suspect. The suspect advanced toward an officer at Washington and Davis, who retreated until her path was blocked. She fired twice at the on-coming suspect, who was mortally struck.

OIS Investigations Update

The previous OIS Quarterly Report was presented to the Police Commission on February 4, 2015. Since that report:

- **Four (4) investigations** (12-001, 12-004, 13-001, and 13-002) were finished, with corresponding summary letters presented to the Police Commission. These cases are closed.
- **One (1) investigation** (12-003) was presented to the FDRB, signed off by the COP, presented to the Police Commission in a summary letter report, and completed. This case is closed.
- **Two (2) investigations** (15-003 and 15-004) were opened.



Open OIS Cases Summary

As of April 2, 2015, there are **eighteen (18) open OIS investigations**, as follows :

- **Three (3) criminal investigations** have been completed, with DA charging decisions received. These cases will be presented to the next FDRB.
- **Twelve (12) criminal investigations** are currently being conducted and reviewed by the Office of the District Attorney. The SFPD administrative investigation is tolling.
- **Three (3) cases** have active SFPD criminal and administrative investigations.
