Reporting Homeless Issues

If you are concerned about a homeless person in San Francisco, call the Department of Emergency Management (DEM) at 3-1-1 or email healthystreets@sfgov.org.

The 3-1-1 staff will talk with you to determine the appropriate City Agency or combination of Agencies to respond for services. DEM houses a "Healthy Streets Operations Center" (HSOC) staffed with representatives from the Police Department, Department of Public Works (DPW), Department of Health (DPH), and the Department of Homelessness and Supportive Housing (DHSH). The HSOC is operational Monday through Friday from 7:00 am to 4:00 pm

If you are concerned for a person who appears to be in distress and needs immediate attention you can call the SFPD non-emergency number 415-553-0123 or in an emergency 9-1-1.

Central Station has recently dedicated six of our police officers to assess and assist with the homeless situation in our District alone!

Our new strategy: One officer meets with a team from the Department of Public Work several days a week at 5:00 am and they navigate through the Central District for homeless outreach and clean-up. Another two officers meet with our local DPW representative daily at 7:00 am and they coordinate to make an additional path through the Central District with the same goal to provide services for our homeless population.





Incidents of Note

Vehicle, Stolen

03/01/18 1051 hrs 1500 BLK of Leavenworth St

Central Station officers responded to a report of a person inside of a victim's vehicle. Officers arrived on scene and detained Suspect #1 next to the Victim's vehicle and Suspect #2 who was sitting in the driver's seat of a getaway vehicle directly behind the victim's vehicle. Officers seized shaved keys from suspect #1 during a search. Officers seized a glass pipe used to smoke methamphetamines from suspect #2 during a search. Officers made contact with the registered owner of the victim vehicle who had seen the suspects acting suspiciously in the area of her vehicle. Officers obtained video footage of the incident, which showed Suspect #1 enter the vehicle and start the ignition of the vehicle. Both suspects were booked at County Jail.

Theft, From Person, >\$950 (Other Than Pickpocket)

03/01/18 1847 hrs Unit BLK of Drumm St

On 1/13/18, the Victim made a counter report regarding the theft of his cell phone by a suspect on a bike in front of 250 Sacramento Street. On 1/31/18, the Victim observed the suspect who had taken his phone on Drumm Street. The Victim was able to take a photograph of the suspect and created a supplemental report with the photograph of the suspect. On 3/1/18, the Victim again saw the Suspect on Drumm Street and contacted police. A uniformed officer arrived on scene and detained the suspect who the Victim identified as being responsible for the theft of his cellular phone on 1/13/18. The suspect was booked at County Jail.

Burglary, Non-Residential, Forcible Entry

03/05/18 1241 hrs 400 BLK of Eddy St

On 2/13/18 a suspect was confronted by a security guard during the commission of a residential burglary. The suspect brandished a weapon at the security guard and fled the scene. Video of the incident was obtained and a crime bulletin was issued. On 2/20/18 a burglary of a non-profit establishment occurred. Responding officers viewed video of the suspect and recognized him as being the same person involved in the incident on 2/13/18. On 3/5/18 the suspect was detained by a Tenderloin District officer who contacted Central's Station Investigations Team. During an interview, the suspect admitted to being involved in both burglaries and was subsequently booked at County Jail for both incidents.

Robbery, With Force

03/06/18 1150 hrs 700 BLK of Washington St

On 3/6/18, uniformed officers responded to 737 Washington Street on reports of a robbery. Officers detained two juvenile female subjects at the location. Officers learned the subjects took a phone from a table while a patron of the restaurant was eating. The victim struggled with subject #1 in an attempt to get her phone back. Subject #1 tossed the phone to subject #2. Both subjects were prevented from leaving the restaurant by the other patrons and restaurant employees. Brass knuckles were recovered from one of the subjects during an arrest search. Both subjects were booked at the Juvenile Justice Center.

Robbery, with Force

03/09/18 1437 hrs 300 BLK of Post St

Uniformed officers were flagged down by loss prevention agents from Saks 5th Avenue who had detained two shoplifters. Officers learned that Suspect #1 entered the store and took a hand bag worth \$1,750.00 from the store without paying for it. When loss prevention attempted to detain Subject #1, Subject #2 attempted to thwart their efforts by threatening them with a weapon. Officers conducted an investigation and learned that Suspect #2 was on active parole for robbery. Officers obtained a confession from Suspect #1 regarding the theft of the handbag. Both subjects were booked at County Jail.

San Francisco Police Arrest Armed Robbery Suspects

On January 2nd at approximately 10:50 PM, San Francisco Police responded to the 100 block of Powell Street regarding a robbery of a convenience store. In this incident, a masked and gloved armed suspect entered the store, went directly to the manager's office, and demanded money from an employee. The suspect fled to a waiting vehicle, driving away with over \$21,000 in cash.

The SFPD Night Investigations Unit (NIU) responded out to the scene to conduct an investigation, and were able to secure valuable video surveillance and witness statements. Leads were generated, and investigators assigned to the SFPD Robbery Unit were able to identify three suspects. Based on evidence obtained, arrest warrants for all three suspects were issued.

The investigation revealed that two employees who were present at the time of the robbery were actually involved in the commission of the crime. On January 6, 2018, the following suspects were taken into custody without incident:

Anthony Sherwood, 21 years old, Daly City resident, arrested and booked into San Francisco County Jail on felony charges of grand theft, first degree burglary, conspiracy, embezzlement, and misdemeanor making a false report of a crime.

Lionel De Leon, 26 years old, San Francisco resident, was arrested and booked into San Francisco County Jail on felony charges of grand theft, first degree burglary, conspiracy, embezzlement, and misdemeanor making a false report of a crime.

As the third suspect involved was believed to have fled the state, SFPD's Special Investigations Division became involved. On February 20, 2018, Dezmond Tayeh, 24 years old, San Francisco resident, was taken into custody without incident and booked into San Francisco County Jail on felony charges of grand theft, second degree burglary, and conspiracy.

Due to pending investigatory matters, booking photos are not available at this time.

Ghirardelli Square Vehicle Break-in Arrest

On Sunday, February 25, 2018, San Francisco Police officers from Central Station's Plainclothes Unit responded to a call for service at Ghirardelli Square area parking garage regarding auto burglaries. At approximately 7:30 PM, they observed an unknown male at the corner of Beach Street and Larkin Street who matched the suspect's description. Officers immediately conducted an investigation and learned there had been several burglarized vehicles in the immediate area, associated with a suspect vehicle that had driven through a nearby parking garage gate without paying the day before. Officers broadcast a description of the suspect and suspect vehicle.

The plainclothes officers observed a suspect walking towards a vehicle matching the description of the suspect vehicle. The suspect entered the vehicle and was immediately detained by plainclothes officers. A second suspect was located in the backseat of the vehicle and detained. A firearm was located inside the suspect's vehicle.

Through the course of the investigation it was determined the suspect was involved in the burglaries of the vehicles and several other vehicle break-ins from the day before. Both suspects were placed under arrest.

The suspect, identified as 22 year-old Oakland resident Jalen Bryant, was booked at the San Francisco County Jail on the following charges: possession of burglary tools, possessing a concealed firearm in a vehicle, possession of a loaded firearm, possession of an unregistered firearm, vandalism and a probation violation.

The second suspect, 22 year old Antioch resident Pride Scott, was cited and released from Central station on the following charges: possession of burglary tools and providing a false identification to a peace officer.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles to locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Central Station officers coordinate with city
 agencies to provide outreach and assistance to rehabilitate those who are dependent on
 illegal drugs and outreach to homeless individuals to connect them with resources and
 support.
- <u>Foot Patrols</u>: Central Station have beat officers assigned to Union Square, Fisherman's Wharf, Chinatown, North Beach and Market/Drumm area.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Central Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Auxiliary Law Enforcement Response Team

(ALERT)



Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- 2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- 3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
