San Francisco Housing Authority Developments, Notification and Procedures (Re-issue DB 12-182)

The San Francisco Police Department and the San Francisco Housing Authority continue to work together to improve the quality of life for residents of Housing Authority Developments and properties falling under Section 8 guidelines.

There are approximately eighteen Housing Authority Developments in San Francisco. Twelve of the developments are family residences and the other six are mixed to include family residences, Section 8 and market rent. These six developments are all HOPE VI properties and are run and maintained by private management. The Housing Liaison Unit maintains a current roster of all tenants and only the addresses for Section 8 properties. All sworn members should become familiar with the Developments in their district.

To ensure a safe community for all residents, the San Francisco Housing Authority (SFHA) has a no tolerance policy towards tenants, their family members and guests who are in possession of drugs for sales and for possession of illegal weapons. Tenants who are in possession of drugs for sales or possession of illegal weapons, and are involved in violent crimes are subject to eviction from these developments.

Besides enforcing laws on SFHA properties, the sworn members in the Housing Liaison Unit need documented police incident reports involving weapons, drugs, and violent crimes that involve SFHA residents to create a case for prosecution and eviction.

SFHA residents are subject to eviction for crimes they commit on or off of Housing Authority properties. Members are reminded that if a Housing Authority resident commits a crime outside of Housing Authority properties, the members shall email a copy of the report to the Housing Liaison Unit SFPD.HALiaison@sfgov.org. A list of all SFHA properties are attached to this bulletin and can be obtained from the Department Intranet under "Bulletin Board."
