Officer-Involved Shooting 11-004

Incident Date: July 16, 2011

Location: Mendell Plaza (Third and Palou Sts.)

Finding: In Policy

At approximately 1640 hours on July 16, 2011, two uniformed officers were conducting high visibility enforcement of quality of life issues around the Third and Palou Sts. MUNI platform. The officers detained a suspect for fare evasion. The suspect sprinted from the officers, who chased him into Mendell Plaza. Unbeknownst to the officers, the suspect was a parolee wanted in connection to a Seattle, WA homicide. Using a reach-around draw, the suspect fired at the pursuing officers. The officers returned fire, striking his left leg twice. The suspect attempted to fire at the officers again, causing an accidental, self-inflicted mortal wound.



Officer-Involved Discharge 001-13

Incident Date: February 10, 2013

Location: Belmont, California

Finding: Not In Policy

At approximately 0100 on February 10, 2013, an off-duty recruit officer negligently discharged one round from a 12-gauge shotgun while inside his apartment. The discharge caused damage to his own and an adjoining apartment, but there were no injuries.
