Incident Date: March 16, 2013

Location: Dublin, CA

Finding: Not In Policy

While at home, an off-duty officer was repairing a privately owned handgun. Upon completion, the officer began to disassemble the handgun in order to clean and oil it. In the course of doing so, the officer accidentally discharged his weapon, striking his left leg.



Officer-Involved Discharge 002-13

Incident Date: March 18, 2013

Location: Alvord Lake, Golden Gate Park

Finding: In Policy

At approximately 1650 hours on March 18, 2013, an officer on a fixed post in the area of Alvord Lake noticed a man slumped forward over a dog. As the officer investigated, the dog became increasingly aggressive, eventually attacking and biting the officer. The officer fired twice at the dog, killing the animal.
