Report Back

FDRB Chair requested follow-up on recommendations for OID 002-16 and OIS 13-003.

OID 002-16

Captain Falvey reported:

- Involved officer completed recommended retraining.
- SFPD tactical standards exceed National Tactical Officer (NTOA) recommendations.
- The industry standard for officer involved in an unintended discharge is the agency's discretion.
- The presence of children is a consideration in the threat assessment.

OIS 13-003

Sergeant Crudo reported:

Involved officer POST-certified retraining, per recommendation, scheduled for 10/24/16.

FDRB Chair requested that training resulting from OIS/OID incidents in future be coordinated with Training Division.

Officer Involved Shooting 14-003

Incident: Saturday, March 8, 2014

Location: 1300 block of Florida Street

Finding: In Policy

Two uniformed officers assigned to the Mission Station housing unit responded to a report of vandalism to a vehicle. When officers approached the vehicle, the driver backed up, then deliberately steered his vehicle toward one of the officers, who was attempting to move to cover. His cover officer fired at the driver, but did not strike him. A bullet fragmented and struck the partner. The suspect fled the scene and was later apprehended in another county.

OIS Investigations Update

The previous OIS Quarterly Report was submitted to the Police Commission on April 7, 2016. Since that report:

- One OIS investigation (OIS 14-003) was presented to the FDRB and the summary report submitted to the Police Commission. This investigation is closed.
- One OIS investigation (OIS 16-003) was initiated on October 14, 2016.

As of December 12, 2016, there are **fifteen (15) open SFPD OIS investigations**:

- Twelve (12) criminal investigations (14-005, 14-006, 14-007, 15-001, 15-002, 15-003, 15-004, 15-007, 15-008, 15-009, 15-010, 16-001) are under review by the Office of the District Attorney of San Francisco for charging decisions. The corresponding SFPD administrative investigations are tolling.
- One (1) criminal investigation (15-006) has been completed by the San Mateo Police Department; the investigation is administratively tolling because of injuries sustained by the involved officer.
- Two (2) criminal investigations (OIS 16-002 and OIS 16-003) are an active criminal investigation by the SFPD Homicide Detail, ME, and/or the DA). The corresponding SFPD administrative investigations are tolling.
