Firearm Discharge Review Board Summary



Firearm Discharge Review Board

Since the last presentation to the Police Commission, on November 8, 2018, the Firearm Discharge Review Board convened twice: December 11, 2017 (4th Quarter 2017) and March 2, 2018 (1st Quarter 2018).

The FDRB reviewed the following completed investigations:

- OIS 14-005
- OIS 14-007
- OIS 16-002



Officer Involved Shooting 14-005

Date & Time: Thursday, September 25, 2014 at approximately 06:00 Hours

Location: Intersection of California and Battery Streets

Numerous officers responded to a report of a roll-over car collision at Battery and California Streets. The description of one involved car matched an armed carjacking vehicle that had been pursued by CHP officers from Richmond to San Francisco. As unknowing citizens approached this vehicle to render assistance, the occupant fired at them, narrowly missing a Good Samaritan. Officers attempted to persuade the armed suspect's surrender. When the suspect emerged from his car and pointed a firearm at officers on scene, six uniformed officers fired at the suspect, fatally striking him.

Recommendation: In Policy (COP Concurred)



Officer Involved Shooting 14-007

Date & Time: Thursday, November 6, 2014 at approximately 19:51 Hours

Location: 900 Block of Connecticut Street

Four plainclothes officers assigned to Bayview Station observed a suspected narcotics transaction in the area of public housing 900 Connecticut Street. As two of the officers began to approach the four involved subjects, two men attempted to leave the scene. An officer pursued one of the fleeing suspects. The suspect produced a firearm from his hip area and pointed it at the officer. The officer fired at the suspect, wounding him. The suspect was taken into custody.

Recommendation: In Policy (COP Concurred)



Officer Involved Shooting 16-002

Date & Time: Thursday, May 19, 2016 at approximately 09:50 Hours

Location: 100 Block of Elmira Street

Two uniformed officers conducting Vehicle Theft Abatement operations encountered a stolen, occupied vehicle parked on the 100 block of Elmira Street. The driver attempted to flee the scene but crashed into a parked truck. When the officers approached the driver on foot, the suspect again attempted to drive away, almost striking one of the officers, before heading toward the other officer. The second officer fired one time and fatally struck the suspect.

Recommendation: In Policy (COP Concurred)

Additional: DGO 5.01 and 5.02 subsequently revised.

Open OIS Cases Summary

As of April 11, 2018, there are **seventeen (17) open SFPD OIS investigations**. This includes five new cases opened since the last presentation to the Commission (11/08/17). Of these open cases:

- **Five investigations were opened** (OIS 17-007 (12/01/17); OIS 17-008 (12/18/17); OIS 18-001 (02/17/18); OIS 18-002 (03/06/18); and OIS (03/21/18).
- **Seven (7) OIS cases have active criminal investigations with the SFPD and/or DA's office** (15-010, 16-001, 17-001, 17-005, 17-006, 17-007, 17-008, 18-001, 18-002, 18-003).
- **Five (5) cases have active ME or Coroner investigations** (17-005, 17-007, 17-008*, 18-002, 18-003).
- **Charging decisions were received from the SFDA for two (2) open cases (OIS15-009 (11/14/17) and 17-005 (12/05/17)).**
- **One (1) criminal investigation was completed by Richmond Police Department (OIS 17-008).** A coroner's inquest (Contra Costa County) is still pending in this case.
