Assignments Effective November 13, 2021

Method Used to Determine Assignments

These assignments are a result of a collaborative process in which all Deputy Chiefs ("DCs") and the Executive Director of the Strategic Management Bureau ("ED") met to discuss and prepare a proposal to the Assistant Chiefs and Chief recommending new promotees' assignments and any subsequent assignment changes necessary. The Deputy Chiefs and Executive Director (DCs/ED) took the following into consideration:

- Individual request DCs and Commanders had the opportunity to provide their top two choices for assignment.
- Skill set and strengths align with the need and/or purpose of the command.
- Professional growth (i.e., rotation of assignments and/or the duration assigned to existing command)
- Readiness for and/or familiarity with the function.
