Re: Additional Suggested Materials on Electronic Controlled Weapons (aka "Tasers")

Dear Commissioners Sonia Melara and Bill Ong Hing:

Below I have suggested four articles on the topic of Electronic Controlled Weapons (aka "Tasers") to supplement the materials our agency previously recommended in our May 18, 2017 letter to you.

1. **Washington Post Article on 2015 Deaths in Incidents Where Police Used Tasers**

On November 26, 2015, the Washington Post published an article that focused on incidents resulting in the individual's death in which police used tasers. This article is part of the Washington Posts' series in which the Post began compiling a database of all fatal shootings nationwide by officers in the line of duty.

2. Baltimore Sun's Analysis of Three Years of Taser Incidents in Maryland

On March 19, 2016, the Baltimore Sun published an article about its data analysis of all taser incidents in Maryland over a three-year period. The Baltimore Sun's analysis indicated that police agencies across the state have predominantly used the devices against suspects who posed no immediate threat. The study also established that in hundreds of cases, police did not follow widely accepted safety recommendations.

3. Amnesty International Reports on Tasers

In 2007 Amnesty International issued a statement of concern about taser-related deaths to the United States Department of Justice.

In its 2015-2016 *The State of the World's Human Rights* report, Amnesty International stated that the numbers of Taser-related deaths since 2001 is at least 670 and that most victims were not armed and did not appear to pose a threat of death or serious injury when the Taser was deployed.

4. Chapter on the Medical Testimony Concerning Death of Mr. Dziekanski Presented to the Braidwood Commission


The Braidwood Commission's reports on the death of Robert Dziekanski at the Van Couver International Airport in which police used an electronic control weapon on him, includes summaries from 14 medical experts in forensic pathology, cardiology, electrophysiology, forensic pathology, emergency medicine, TASER research, psychiatry, addiction medicine, forensic psychiatry and epidemiology. The Braidwood Commission's Executive Summary of the incident (pp.1-16) and chapter on the cause of death that includes summaries of the medical experts' opinions (pp.273-338) are attached.
