At the meeting of the Police Commission on Wednesday, January 11, 2017, the following resolution was adopted:

RESOLUTION 17-3

AWARDS GRANTED TO MEMBERS OF THE POLICE DEPARTMENT

WHEREAS, the following named members of the Police Department are commended for courageous service under the provisions of General Order 3.09, Section I.A.1 of the San Francisco Police Department, as approved by the Awards Committee on October 4, 2016; and
