Crime and Enforcement Update

Hot Prowl Burglary, 233 Silliman, March 17, 9:01 a.m. Bayview Officers Hui and Kwan responded on the call of a burglary in progress and spoke with a man who had just seen a suspect about to enter his home through an open patio door leading to his backyard. The caller told the suspect he was going to call the police and the suspect fled. The caller, while on the phone with Dispatch, saw the suspect join up with three additional suspects in front of his home and then flee the area. The officers interviewed two additional witnesses on the street, both of whom had phoned police upon seeing the suspects attempting to enter numerous homes on the block. The suspects are described as follows: suspect one is a black male, 17-20, 5'8", 180, wearing dark clothing with a red symbol or picture on the chest; suspect two is a black male, 5'8", 140, wearing dark clothing; suspect three is a black male, 5'4", 135, wearing dark clothing and carrying a black backpack; suspect four is a black male, 5'6", 145, wearing dark clothing (050 298 954).

Illegal Lodging, Quint and Custer, March 17, 11:22 a.m. Bayview Officer Lavin responded on a complaint of a homeless encampment and found two men sleeping in tents on public property. The tents were

surrounded by numerous shopping carts, personal property, recycling items, and other debris. Additionally, two dogs were tied up in the encampment. The two campers had been contacted by Officer Lavin on numerous prior occasions and told her they had no intention of going into any homeless shelters. Since they had been cited numerous times in the past, they were charged with a "continuing offense" public nuisance complaint (050 299 532).

Parole Violation, 1738 25th Street, March 17, 2:31 p.m. Members of the department's FRET Unit (Fugitive Recovery Enforcement Team) responded to a home on 25th Street and arrested a man wanted for violation of his parole (050 300 305).

Possession Crack for Sale, 3rd and Revere, March 17, 2:41 p.m. Bayview's plainclothes officers responded to 3rd an Revere on a complaint from a nearby resident that drug dealers had been hiding in the area every time police officers drove by. The officers found two men engaged in what appeared to be a drug transaction and detained them. The first man, who has been admonished regarding his drug loitering on August 4, 2005, August 14, 2004, October 12, 2004, and January 28, 2005, was arrested for his drug-related loitering. On October 12, 2004, the man was booked for possession of crack cocaine, and more than \$17,000.00 was found in his vehicle at the time. The officers searched the man's vehicle again and found a phony "WD-40" can with a removable base. When the officers opened the can, they found a large amount of crack cocaine and almost \$500.00 in currency. The suspect was searched at Bayview Station and an additional amount of crack cocaine was found hidden in his buttocks area. The suspect, living on the 3100 block of San Jose Avenue, was booked for numerous drug charges. The second suspect, also known to the officers through numerous contacts, was not in possession of any drugs and was released at the scene (050 300 424).

Heroin Arrest, Fitzgerald and Jennings, March 17, 3:07 p.m. Bayview's plainclothes officers were on patrol when they saw a man well known to them as a drug user sitting on a milk crate on the sidewalk. The officers exercised the man's search condition and found heroin hidden in his sock. The man, a transient, was booked for possession of heroin and violation of probation (050 300 468).

Warrant Arrest, 900 Silliman, March 17, 3:30 p.m. Members of the department's FRET Unit (Fugitive Recovery Enforcement Team) responded to a home on Silliman Street and arrested a man wanted for violation of his parole (050 300 480).

Warrant Arrest, Theft Case, 345 Williams, March 17, 3:26 Bayview Officer Coleman responded to the FoodsCo Store on the report of a shoplifting suspect in custody. The female suspect had been caught stealing several items by store security, and was found to have five prior convictions for theft, so she was booked for "petty theft with a prior conviction." The woman was also charged with an outstanding drug warrant (050 300 979).

Marijuana Arrest, Warrant Arrest, Mendell and Newcomb, March 17, 7:05 p.m. Bayview plainclothes officers were on patrol in the parking lot of the Joe Lee Gym when they came across two men seated in a vehicle, one of whom was smoking marijuana and drinking from a paper cup. The man was asked by the

officers what he was drinking and he responded, "Vodka and Minute Maid fruit punch." The man, living on the 1400 block of LaSalle, was booked for possession of marijuana, drinking in public, and drug related loitering. He was also charged with an outstanding arrest warrant (050 301 535).

Warrant Arrest, 1698 LaSalle, March 17, 8:06 p.m. Bayview Officers Erb and Johnson were on patrol when they stopped to speak with two men loitering at Newhall and LaSalle. The officers found that one of the men, living on the 2000 block of Thomas, was wanted for an outstanding warrant. The man was booked for the warrant (050 301 604).

Carjacking Arrest, Jennings and Revere, March 17, 9:35 p.m. Bayview Officers Cahill and Wise responded to Keith and Palou on a call of shots being fired and met with three victims who told the officers they had just been "carjacked." The victims told the officers two men, one of whom was armed with a gun, had just stolen their vehicle at gunpoint. The owner of the vehicle, who is several months pregnant, feared for her life and gave the car keys to the suspects, who then fled in the victim's vehicle. A description of the suspects and the vehicle they had just stolen was put out over the air and, moments later, Bayview Officers Johnson and Erb spotted the vehicle driving west on Palou. The officers attempted to stop the vehicle, but it took off at a high rate of speed. The vehicle was found again and the officers stopped it at Industrial and Barneveld. The victims identified the suspects as the carjackers and they were arrested. The first suspect, living on the 1100 block of Oakdale, was booked for carjacking, robbery and conspiracy. The second suspect, living in Pittsburg, was booked for the same charges, as well as for being an unlicensed driver (050 301 858).

Attempted Kidnapping, Waterville and Thornton, March 17, 11:14 p.m. Bayview Officers Lane and Winesberry responded on the call of a woman screaming for help and located a young woman who told them that she had been standing at Silver and San Bruno waiting for the bus when she saw a man walk into the "White Palace" liquor store and inadvertently drop a wad of money onto the ground. The victim then saw a nearby homeless man pick up the money and put it into his pocket. When the man exited the liquor store he realized he had dropped his money and accused the victim of taking it. The man then began to beat and choke the victim and she ran away. The suspect entered his car and pursued the victim, eventually overtaking her at Waterville and Thornton, where he threatened to kill her and attempted to pull her into his car (there was a second man already in he car). The victim escaped and eventually hailed a passing police officer. Suspect one is a black male, 20-25, 6'0", 165, wearing green and blue clothing. Suspect two is a Hispanic male, 5'4", 165, wearing a white and green jersey and blue shorts. The suspect vehicle is a Chevy Impala, green in color (050 302 072).
