Supervisor Maxwell Legislation Approved at January 25 Board of Supes Meeting

Supervisor Maxwell's legislation changing parking along the 1200 block of Fitzgerald Avenue, designed to assist with law enforcement activities and to create a more livable neighborhood, was unanimously approved by the Board of Supervisors on Tuesday, January 25.

Crime and Enforcement Update

On January 26, at 5:30 p.m., Bayview Officers Lew and Coleman responded to Mariposa and Rhode Island on a call of a man breaking into a car. The officers found a man at the scene who matched the description given and detained him. The man was in possession of two screwdrivers and the officers contacted the caller in order to gather additional information. The caller told officers that he had seen the detained man leaning into a parked car through a broken window. The officers then contacted the owner of the vehicle who also responded to the scene. The owner stated that nothing was missing from his car, but he also stated that his window had been intact when he parked his vehicle. The detained man, living on the 1800 block of Oakdale, was booked for possession of burglar tools (050 100 826).

On January 27, at 2:20 a.m., Bayview Officers responded to 3rd and Kirkwood on the report of two men breaking into a trailer. As the officers arrived, a man was seen running away from the area and he was detained. The caller in the case was unable to tell the officers if the detained man had been

involved in the burglary, but he provided the officers with a video tape of the event. The officers viewed the tape and determined that the detained suspect was not connected with the burglary, however, he did have an outstanding warrant for his arrest and was subsequently booked for the warrant (050 102 355).

On January 27, at 7:00 a.m., Bayview Officer Remedios, accompanied by Burglary Inspectors, responded to a home on Lucy Street to conduct a probation search as part of a burglary investigation. The officers located an individual in the premises who turned out to be a sex offender who had failed to register his new address. The man, who stated that he was now living on Lucy Street, was booked for failing to register as a sex offender (050 102 559).

On January 27, at 10:30 a.m., Bayview Officer Remedios responded to 6600 3rd Street on a theft call and determined that the suspect in the theft case was wanted for a parole violation. The subject would not admit to committing any burglaries, although he stated that the bicycle stolen in the most recent case (200 block of Texas) was probably at 7th and Mission Streets. (Officers later searched this area to no avail). The man was booked for burglary and violation of parole (050 102 452).

On January 27, at 3:56 p.m., Bayview Officers Escobar and Calaunan responded to Newhall and Oakdale on a call of two men selling drugs out of a white van with no plates. The officers located two men near the van and detained them, eventually determining that one of the men was wanted for an outstanding warrant from San Mateo County charging him with possession of crack cocaine. The man was booked for the warrant (050 105 406).

The subject of the search warrant was detained and released, pending a more thorough investigation into the case (050 105 218).

The victim told officers that she had parked her car on the 1300 block of Keith and was walking home when she was approached from the rear by a man who grabbed her purse and knocked her to the ground. This is the third time that this man has been charged with violating the stay-away order on this same case. He is apparently quite fond of this particular liquor store and has no intention of altering his shopping patterns (050 105 917).

The officers located the female caller who told them that her boyfriend of one week had just beat her with his fists and threatened to beat her with a bike chain. They took this as a refusal to provide a statement and booked him for aggravated assault and making terrorist threats (050 105 967).
