THE BELOW LISTED INCIDENTS WERE SUBMITTED BY INDIVIDUALS OF BAYVIEW STATION:

Monday, May 15, 2006, 5:25 PM - Robbery with Caustic Chemical - Keith Street and Hudson Avenue - CS# 060 517 039 - Officers Cruz and Festa reported that a woman was walking on Hudson Avenue when she was approached by a group of young girls. The woman felt a liquid strike her face and a burning sensation in her eyes. One of these young girls yanked the victim's cell phone from her belt. The woman screamed for help.

Numerous witnesses heard this and rendered aid. Paramedics responded to the scene. It was determined that the woman was sprayed with pepper spray, which delivers a temporary, albeit a painful burning sensation to one's eyes. The suspects were described as three black female juveniles between 14-16 years old. One was identified as heavy set and wearing pink clothing. They all ran east on Hudson Avenue.

Monday, May 15, 2006, 5:36 PM - Warrant Arrest - Evans Street at Mendell Avenue - CS# 060 427 192 - An alert Officer Pasqua noticed that a male that was wanted for Assault with a Deadly Weapon was getting into the passenger side of a vehicle. He told Officer Robinson of the felon and they pulled the car over as it drove off. The suspect was arrested without incident.

Tuesday, May 16, 2006, 1:40AM - Auto Burglary - Hollister Avenue and Hawes Street - CS# 060 514 091 - Officer Rodriguez and Correa responded to this location on report of an auto burglary. The caller provided the police with a description of the suspect and the vehicle that the suspect was going into. Sgt. Dempsey, who was operating incognito, also responded and found the suspect just a block away from the reported location.

The suspect had tools in his possession that had initials engraved in them. They also happened to be the initials the registered owner's car that was

reported being broke into. The owner of the tools and the car were located. It was determined that this suspect committed burglary and was subsequently booked.

Tuesday, May 16, 2006, 5:50 AM - Auto Burglary, Narcotics Possession - Holyoke and Wayland Streets - CS# 060 518 350 - Officers Singh and Farrell responded to a call that someone was breaking into a van. The caller gave dispatch a description of a van and the suspect. The officers found the van and the suspect, a woman, was attempting to hide herself between the front seats of the can. The woman was ordered out of the van. In her hand was screwdriver.

The owner of the van was located and she identified some of the property on the suspect as belonging to her. Officer Singh read the suspect her Miranda Rights. The suspect said to the Officers that she was a drug addict and she walking around the neighborhood and checking car doors to see if any were unlocked. The suspect also admitted to finding another car nearby that had its car door unlocked. The suspect took out a duffle bag that contained two passports, one social security card, and other items. Police were able to find the vehicle and its owner, reuniting him with his property.

The woman as also had numerous pieces of crack cocaine in her possession. She was booked for auto burglary and narcotics charges.

The thing to take away in this case is to obviously lock your car doors. But also be mindful of what is in your car. This person that left his passports and social security card in his car was spared a lifetime of identity theft issues. Also what you think may not be valuable in the eyes of a would be thief often is. Frequent readers of this update already know street level narcotics addict will steal approximately 150-200 thousand dollars of merchandise to support their habit.

Tuesday May, 16th 2006, 8:10 PM - Robbery with a knife - 3rd Street and Palou Avenue - CS# 060 521 745 - A young man was walking in the area of 3rd Street and Palou Avenues when he was approached by a man. The man held a knife the victim's throat and demanded the victim's money and cell phone. The suspect then fled on foot.

Friday, May 19, 2006, 3:35 PM, - Robbery with a Gun - 1100 block of Fitzgerald - CS# 060 532 548 - Officer McPherson reported that two men that had just completed work were standing outside of a building on the 1100 block of Fitzgerald Avenue, counting out the day's proceeds. They were approached by a gun wielding man who told them, "Don't move." The man took the wallets from the pants' pockets of the men.

and told him who committed the crime. The Robbery Bureau is following up with this lead.

Friday, May 19, 2006, 11:50 PM, - Heroin for Sales - 5000 Block of Third Street - CS# 060 534 196 - On Friday evening California Highway Patrol took to the streets of the Bayview District in a comprehensive traffic enforcement program. In addition to increased traffic safety, another goal is to get unlicensed drivers and fugitives off the street. During a traffic stop, Officer Johnson and Erb backed a CHP officer up on a traffic stop. A warrant check revealed that the passenger was fugitive from Sonoma County, for numerous burglary and forgery charges. During the booking search a large amount of Heroin was found on her person. In addition to her warrants, the woman, a San Francisco native, was also booked for heroin, possession for sale.

Saturday, May 20, 2006 - Robbery with Force - 30 Block of Goettingen - CS# 060 535 570 - A woman was a victim of robbery on this date. What makes this incident so unfortunate is that the victim's small children were present and witnessed this act. The woman was getting into her car that was parked on the street when a small white car with four black male juveniles pulled up and grabbed her purse. The woman tried to hold on but the purse was ripped from her. Her purse contained her wallet, keys, and cell phone.

Saturday, May 20, 2006, 12:40 PM, 300 block of Goettingen, Purse snatch (case # 060535570): The victim was getting into her car when a car containing several African American teenage males came right beside her. The passenger in the car then grabbed the victim's purse. The driver then drove off, causing the victim to release the purse so the car wouldn't drag her.

Saturday, May 20, 2006, 5:20 PM, 750 Kirkwood, Assault on a child (case # 060536807): The victim was walking up the stairs to her apartment when a neighbor confronted her. She was carrying her 3-year-old son in her arms at the time. The neighbor accused the victim of having a problem with her family. The victim denied having any problems and tried to continue up the stairs. The suspect then slapped the victim. Before the victim could run away, the suspect took another swing at the victim, but instead hit the baby on the side of the face, giving him a black eye. The suspect then ran off.

Saturday, May 20, 2006, 8:00 PM, Apollo and Thorton, Robbery (case # 060536932): The victim was leaving his car when the suspect walked up to him and asked him for money "to bail his mother out of jail." The victim actually removed his wallet from his pocket and started to look for cash to give to the suspect. The suspect then grabbed the wallet. During the struggle, the victim was pushed to the ground and the suspect took off in a

silver American sedan. The suspect was described as an African American male, dark complexion, late teens or early 20's, 5'11", 200 pounds wearing a white t-shirt and jeans.

Saturday, May 21, 2006, 9:25 PM, Bayview Station, Internet fraud (case # 060537071): The victim came to Bayview Station to report that he had been the victim of fraud on the internet. The victim had bought a diamond on EBay, for an unusually inexpensive price. However, when the "diamond" it was not a diamond, but an imitation. Remember, if it is too good to be true ...

Sunday, May 21, 2006, 4:00 AM, 752 Kirkwood, Shooting (case # 060537924): If you or your children have profiles on myspace.com, please read this incident carefully. A group of teenagers, some from San Francisco and some from Woodside and Menlo Park had been communicating on myspace.com and they decided to meet and party. One member of the party was not a teenager, but a 26 year old member of the Big Block gang that claims Harbor Northridge as their turf. The Big Block and other San Francisco gangs have been using myspace to recruit members as well as brag about their exploits. This group of myspacers, some as young as 14 were hanging out at 4 in the morning in front of 752 Kirkwood, in the Harbor Northridge projects when someone opened fire, hitting 4 of the group. The target appears to be the gang member since he was hit several times leaving him in critical condition still. However, 3 of the teenagers were also hit, fortunately not critically. They were all treated at San Francisco General and released.

Sunday, May 21, 2006, 9:35 AM, 2400 San Bruno, Robbery with force (case # 060538386): The victim told arriving officers that he was working behind the counter at 2400 San Bruno when two suspects came into the store, grabbed him and took two boxes of cigarettes with approximately 60 cartons inside. The suspects are described as black males, perhaps in their late 20's or early 30's, one 6', 170 pounds, the other 5'11', 240 pounds. They left the scene in a white pickup truck.

Sunday, May 21, 2006, 12:21 PM, 700 Jamestown, Homeless warrant arrest (case # 060538916): Proposed by Sgt. Moran and supported by Captain Pardini, a new footbeat has been created in the southern part of the Bayview District to combat crime around Quesada, Revere, Shafter, Thomas and Underwood east of 3rd Street. If successful and funding is available, this will become a regular foot beat for the Bayview. Homeless coordinator Officer Lavin and Permit Officer George were working the 48 beat when a citizen reported drug usage in a car at 700 Jamestown. The beat officers responded and found a homeless woman living in a car. Warrant checks revealed that she had a \$30,000 warrant for her arrest. She was booked on the warrant at the County Jail.

Monday, May 22, 2006, 1:00 PM, 2901 San Bruno, Sales of BB Guns/Fireworks (case # 060542246): Officer Gasanyan is the beat officer for the Portola shopping district on San Bruno Ave. On May 19th, Officer Gasanyan had advised the owner of the 99 Cents Plus Store that she could not sell either BB guns or fireworks in the city and county of San Francisco. This issue has become particularly important recently since BB guns have been appearing at schools. Unfortunately, it is not always possible to tell the difference between the BB guns and a real gun from a distance. It is conceivable that a student with a BB gun could become a shooting victim if the BB gun is mistaken for a real gun.

On this date, Officer Gasanyan was patrolling the Portola beat when he noticed that both fireworks and BB guns were back on display in the 99 Cents Plus Store window. To make certain that there were no language miscommunications this time, Officer Gasanyan requested that Officer Kwan respond to the scene and speak to the owner of the store again, but this time in Cantonese. The owner claimed that she didn't realize that there were still BB guns and fireworks on display and blamed her son for putting the gun and fireworks back in the window. The owner stated in Cantonese that she understood that she could not sell the guns or the fireworks and that she would not sell them any more.

If you see BB guns or fireworks on sale in the 99 Cents Plus Store or any other store in the city, you can call either dispatch or Bayview Station directly. Calling might save a child's life someday.

Monday, May 22, 2006, 3:30 PM, 800 block of Arkansas, Consumer Complaint (case # 060543545): the complainant said that she had called the Absolute Appliance Repair Shop to come and give her an estimate to fix her washing machine. The repairman arrived, looked at the washing machine briefly and said it would be \$350.00 to repair the washer. Concerned that he had not given her an accurate estimate due to the brief inspection, the complainant told the repairman that she wanted to get another estimate. The repairman then got angry and told her that nothing was free and that he was going to "make trouble for her." Concerned about his behavior, the complainant then wrote the repairman a check, just to get rid of him. Before he left, the repairman told the complainant that she should watch her back and again that he was going to make trouble for her. The complainant said that she was reporting the repairman's behaviour to the police because she was in fear of the repairman.
