Crimes and Law Enforcement

THE BELOW LISTED INCIDENTS WERE SUBMITTED BY INDIVIDUALS OF BAYVIEW STATION:

Tuesday, 3/28/06, 3:05 PM, 1200 block of Van Dyke, Narcotics arrest (Case # 060333954): Plain clothes officers Coleman and Rightmire were driving on Van Dyke when they noticed three men standing next to a camper which had no license plates on the 1200 block of Van Dyke. This is a well known area for narcotic transactions. The officers stopped to investigate and found that two of the men, including the owner of the camper were on active felony probation for previous narcotic offenses. Because they are on probation, they have agreed to be searched at any time without cause. The officers searched the men and the camper and found 4 baggies with methamphetamine as well as other illegal drug paraphernalia inside the camper. The owner camper was arrested and booked at Bayview Station on narcotics and probation violation charges.

Tuesday, 3/28/06, 5:30 PM, 1300 block of Palou, Robbery (Case # 060334617): The victim was standing in front of his house, when the suspect came and asked him if he could make change for a \$5.00 bill. When the victim pulled out his wallet to check, the suspect grabbed the wallet and fled west towards Keith. The victim later found his wallet on Quesada, less the cash that was in the wallet. The suspect is described as heavy set, African American male, late teens, wearing a navy blue hooded sweatshirt and dark pants.

Wednesday, 3/29/06, 00:30 AM, Ingalls and Carroll, Driving while under the influence of Marijuana (Case # 060339526): Officers Erb and DeGuzman were driving on Ingalls when they saw a vehicle heading towards them without headlights on. Remember this is half an hour after midnight. The officers stopped the car and when they approached it, could smell marijuana smoke

drifting from the open windows of the car. The driver smelled of marijuana and even told the officers that he had been smoking earlier. Officers administered field sobriety tests on the driver which he completely failed. The driver was booked on DUI charges at county jail.

Wednesday, 3/29/06, 11:00 AM, 3400 block of Jennings, Burglary in progress arrest (Case # 060336679): Multiple daywatch officers responded to the 3400 block of Jennings on a report of a burglary in progress. Officers Altofer and McGuire while responding saw an African American juvenile male running away from the scene. When the suspect saw the police, he jumped over a fence. The officers ordered the suspect to stop, but he continued to run away. Officer Altofer was able to outrun the suspect and detained him without further incident. Other officers responded to the house that was burglarized and found that the back door had been kicked off it's hinges. Witnesses pointed officers to a backyard on the 1000 block of LeConte where they found a second suspect hiding.

While maintaining a perimeter around the 3400 block of Jennings, Officer Lewis saw another African American juvenile male running through the backyards on the block. Officers obtained permission to enter the back yards from one of the residents and took the third suspect into custody. The third suspect had a laptop computer with him. The owner of the burglarized residence identified the laptop as his.

On the way to the station, one of the suspects told officers that they couldn't prove that he did it because he made sure that he didn't leave any prints inside. Because they were juveniles, two of the suspects were cited and released into their parents custody, the third suspect was an adult and was booked at Bayview Station on burglary charges.

Thursday, 3/30/06, 9:55 AM, 1300 block of Palou, Attempted Robbery (Case # 060340545): The victim was walking on the 1300 block of Palou, when the suspect came to him and asked him if he had change for a \$5.00 bill. The victim told him no and walked on. The suspect then blocked his way and told him to empty his pockets. The suspect then pointed at another man on the other side of the street who was watching what was happening. The victim felt that both men were involved in the robbery. Fearing for his life, the victim ran from the suspect and called 911. Neither suspect followed him. The suspect was described as an African American male in his late teens, 5'10", 200 pounds wearing a dark hooded sweatshirt and dark jeans. His possible accomplice is also an African American male, 5'9" 160 pounds wearing a dark baseball cap turned backwards and a dark jacket.

Thursday, 3/30/06, 3:00 PM, 1400 block of Bayshore, Hit and Run, Driving under the Influence (Case # 060342957): The suspect, while under the influence of alcohol, decided that he needed a Uhaul truck, but he didn't want to pay for it. Unfortunately, stealing a truck drunk, he hit several

parked vehicles as he left the Uhaul lot and was followed by one of the hit and run victims. The victim then flagged down Lt. Mcdonagh who detained the suspect. The suspect told officers he only had 5 or 6 22 oz beers that day. He also did not have a license and was so drunk, he could not even start the field sobriety tests. He was booked on stolen vehicle, hit and run, driving under the influence and driving without a license charges.

Thursday, 3/30/06, 5:24 PM, unit block of Nichols, Purse snatch (Case # 060342820): The victim was walking home on Nichols, when the suspect approached her and asked her for a dollar. The victim told him that she did not have a dollar and tried to walk by, but the suspect blocked her and grabbed for her purse which was on her shoulder. As the suspect pulled on her purse, the force he used knocked her to the ground. The victim was a 4'10 woman; the suspect is an African American male, 6'5", 220 pounds wearing a black beanie, camouflage jacket and blue jeans. The victim's son recovered his mother's purse in an abandoned nearby unit.

Thursday, 3/30/06, 8:30 PM, unit block of Ledyard, Burglary and Assault with a Firearm (Case # 060343088): The victim was standing in his garage with the door open when the two suspects entered and asked where "Mike" was. The victim told them that no one named Mike lived there and asked them to leave the garage. One of the suspects then pulled out a gun. The victim fled upstairs, but was unable to escape. The suspects then sprayed him in the face with Mace and pistol whipped him on the side of his head. The suspects are both African American males, mid to late 20's. The suspect with the firearm is 6', 190 pounds wearing a light green jacket and dark pants. The other suspect was wearing a black beanie, a paintball mask, a dark green jacket and dark pants.

Friday, 3/31/06, 11:00 PM, 1500 block of Kirkwood, Domestic Violence Battery (Case #060348458): On 4/1/06, the girlfriend of a well known gang member called the police regarding a domestic dispute that took place the previous night. Lt. Bruneman as well as Officers Pasby and Martinez responded. The girlfriend said that she was in an argument with her boyfriend of 1.5 years over a cell phone. It ended with them pushing each other several times, before he left.

Saturday, 4/1/06, 7:00 PM, 1800 block of 26th, Domestic Violence and Resisting Arrest (Case # 060350180): Officers responded to the scene of a domestic dispute. As they arrived, they saw a man matching the suspect description leaving the area. When the suspect saw the police he ran east on 26th. With the officers in hot pursuit, the suspect decided to jump over a fence on the south side of 26th. Unfortunately there is a steep cliff on the other side of the fence and the suspect tumbled down the side of the hill until he landed at the bottom. Being in no condition to run any further, the suspect laid low in the tall weeds, trying to hide. The officers set up a perimeter and called for a K-9 unit. When the dog

arrived and started barking, the suspect gave up. An ambulance was called and he was transported to SFGH. The suspect and his girlfriend had been in a relationship for 5 months. Although she is 4 months pregnant, she decided that her boyfriend is abusive and told him that she is not interested in continuing a relationship with him. Since that time, they have argued several times and her house has been burglarized. A few days prior, he struck her several times during an argument; officers on scene could still see bruises that he had caused. After treatment at SFGH, the suspect was booked on domestic violence and resisting arrest charges at county jail.

Sunday, 4/2/06, 4:30 PM, 1600 block of Kirkwood, Homicide by Firearm (Case # 060352766): The victim, a well known gang member, was standing with some "friends" on the 1600 block of Kirkwood when a 2 door vehicle pulled up to them. The "friends" immediately ran off, leaving the victim to be shot several times, first from the car and then walking up to him and shooting him again. The victim died at SFGH of his wounds.

Earlier in the day, at 10:40 AM, the victim was the target of another attempted shooting on 3rd and Palou (case # 060351699).

Sunday, 4/2/06, 8:50 PM, 336 Lathrop, Fire (Case # 060353388): At approximately 8:50 PM, a local neighbor heard a loud explosion and then saw a plume of smoke and fire coming from 336 Lathrop. The neighbor called 911 and fire responded to put out the fire. Officers were dispatched to the location which is well known to all Bayview officers. The resident of 336 Lathrop was detained, but no new charges were filed.
