Mark Solomon, Mission District resident, discussed concerns regarding homicides in the Mission District.

Chief Fong talked about the Department's Violence Reduction efforts.

Deputy Chief Cashman updated the Commission on the Department's violence reduction enforcement. He talked about zone enforcement strategies.

Dr. Anthony Braga addressed the Commission and talked about his study about gun violence that was done with the Mayor's Office of Criminal Justice.

Commissioner Campos expressed concern about the crime analysis report and that it only goes to August 7th and expressed concern that there's been a lot that's happened in the Mission since August 7th. Deputy Chief Cashman stated that he'd like to reassure the community that the report was based on a six-month time frame and it does not diminish the Department's responsibility to put resources in the Mission.

Commissioner Campos would like to see the clearance rate during the six-month period of zone enforcement as compared to prior years. Commissioner Campos would also like to see how the city is doing as compared to other jurisdictions. He also would like a report more specific to zone 3 as to where the numbers are now as compared to last year.

Commander Murphy stated that there is one more homicide this year as compared to last year.

Commissioner Onek suggested that the report be scheduled closer to the end of the reporting period so that numbers are more current. Commissioner Onek also stated that Dr. Braga is also the Chief Policy Advisor to the Boston Police Commissioner, which is the Chief of Police of Boston, and suggested that the Commission might want to think about having a part-time expert type person who can advise the Chief and the Command Staff on a part time basis.

Commissioner Mazzucco asked Dr. Braga as to what to do with Zone 3 and asked for recommendations as to what the Department can do to improve

the numbers in the Mission District. Dr. Braga suggested that the Department look very carefully as to the nature of the violence that going on there. Dr. Braga stated that the Department should really think about as to what's going on there and maybe refer to best practice models and that the important thing is to develop something that makes sense for the Mission District. He stated that the Department should really think about what's generating the violence in the Mission and thinking about what has worked in the past, what levers may exists that haven't been used before and developing a comprehensive plan for the Mission based on people who are actually working and living in the neighborhood. Dr. Braga also explained the models of "pulling levers" and "cease fire."

Chief Fong stated that the foundation of this concept is that all district station are fully staffed and acknowledged the men and women of the Department for their great work. Chief Fong also talked about the Community Connect initiative. Chief Fong went on to highlight some of the great work done by members of the Department.
