**EARLY INTERVENTION SYSTEM**

Deputy Chief Keohane presented the draft of DGO 3.19, Early Intervention System and briefed the Commission on the status of the Early Intervention System. Deputy Chief Keohane hopes that sometime in January a resolution will be ready to have the order adopted.

Commissioner Lee suggested having a member of the community added to the EIS Board.

Commissioner Campos asked about the status of the RFP. Chief Keohane stated that bids from vendors are due on December 15<sup>th</sup>. Chief Keohane explained that the aggregate data will be provided to the public once the system is up and running.

**MAYOR'S OFFICE OF CRIMINAL JUSTICE PRESENTATION:  
COMMUNITY POLICING**

Ms. Lenore Anderson, MOCJ Deputy Director, gave the Commission an update on community policing in the city. Ms. Anderson described the MOCJ's & SFPD's report on community policing.

Commissioner Campos asked what is the definition of community policing. Ms. Anderson stated that it's a philosophy that emphasize community-oriented problem solving as opposed to responsive only policing strategy.

Commissioner Sparks asked what is the status of this program. Ms. Anderson stated that this is basically a report for existing efforts.

Commissioner Renne asked that presentation of certificates be made that is under the Chief's Report.

- (6) Prepare a master list of community organizations' email list.
- (7) Ask the Chief to have a specific bulletin board be prepared at each district stations, bureau, and department offices, for exclusive use of announcements, suggestions, letters by the Commission to be up to directly correspond to the rank and file.

Commissioner Veronese would like to calendar a meeting for next week agendized the Awards Recommendations.

Commissioner DeJesus would like an update on the policy analyst position.

Commissioner Campos announced that the Commission will meet next week.
