Captain's Message

Did you know that the SFPD recovers countless bikes annually, that are believed to have been stolen? Many of these bikes are never reunited with their owners because they could not be positively identified via serial number or other information that could connect a bike to it's rightful owner.

This does not have to happen and it's as easy as taking a couple of minutes to register your new bike with [SAFE Bikes](#), a program created through the partnership of SFPD, [SE SAFE](#), and some very dedicated community members. [SAFE Bikes](#) is trying to take a bite out of bike theft with bicycle theft prevention education as well registration database that can connect you with your stolen bike faster.

Watch this informative video below then visit [SAFE Bikes](#) for more information and registration requirements. If your bike does not meet the requirements for the registration program, you can still help the SFPD get your bike back to you should it get stolen. Have a photo of the bike and it's serial number somewhere readily accessible, such as your phone. Having this information available when making a police report is crucial in identifying stolen property and affecting potential arrests of person in possession of such property.

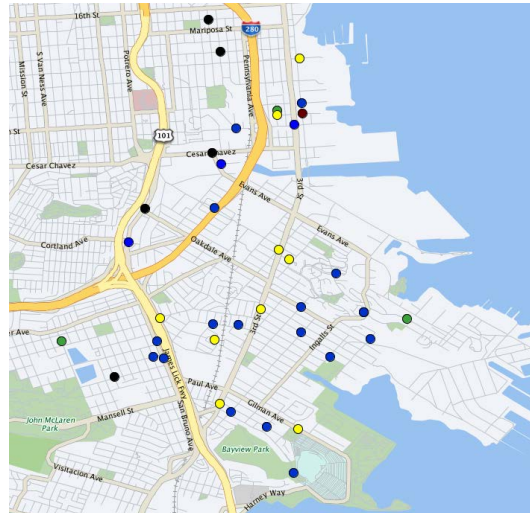
around a decade serving up delicious comfort food to the community and visitors alike. April is a model for young African-American entrepreneurs in the Bayview, and for that we honor her this month!

Homicide Arrest – Illinois / 24th – 3/28/18, 10:22 am

Officers responded on a call of a hit and run involving multiple pedestrians. They located five male victims at the scene with various degrees of injuries. They were transported to ZSFGH for treatment where one of the victims was pronounced deceased. A crime scene had been established, evidence was secured and witnesses were located. The suspect and vehicle were located and arrested in the area of **Geneva and Cayuga**. He was booked on multiple charges that included, homicide, attempted homicide and aggravated assault. (SFPD Case No. 180230103)

Auto Burglary Arrest – 1200 block Eddy – 3/28/18, 6:00 pm

Bayview investigators were able to identify the suspect involved in a March 22nd auto burglary that occurred on the **2500 block of San Bruno** and put out a department wide crime bulletin with the information. An officer in the Northern district recognized the suspect and knew the areas he frequented. It did not take long for the suspect to be located and arrested. He was booked on auto burglary charges. (SFPD Case No. 180214771)

Burglary, Aggravated Assault Arrest– unit block Dakota – 3/29/18, 1:40 am

Officers responded to a call of a suspect attempting to kick in the door of a residence. They met with the 32 year old victim who had been inside the unit with her friend when the suspect broke in. She told the officers that the suspect was a neighbor and acquaintance. They had argued earlier in the day and went their separate ways. The suspect returned, broke down her door and entered the residence. The suspect struck the victim in the face and threatened to kill her. He then fled the scene. The officers located and arrested the suspect in the area. He was booked on burglary, aggravated assault, and threats against life among other charges. (SFPD Case No. 180232610)

Auto Theft Arrest– 26th / Pennsylvania – 3/29/18, 10:12 am

An auto theft victim spotted his stolen car in a taxi cab parking lot and called the police. The responding officers detained the suspect as he approached the vehicle. He initially told them that he had purchased the car and had started to spray paint it a different color “for DMV reasons”. The license plates attached to the car had been issued to a different vehicle that had actually been registered to the suspect. He admitted to having switched the plates in order to avoid getting in trouble. The suspect was arrested and booked on auto theft, possession of stolen property and registration fraud charges. (SFPD Case No. 180200548)

Aggravated Assault – 2600 block San Bruno – 3/30/18, 8:30 pm

A 43 year old victim was waiting for traffic to pass so that he could make a left turn into a bank parking lot when the driver (suspect) of the vehicle behind him started laying on the horn. The victim got out of his truck and asked the driver behind him what the problem was. The driver pulled off past the victim and sped from the area. The victim got back in his truck and entered the parking lot. As he parked, the suspect drove into the lot. The suspect got out and began yelling at the victim. He produced what appeared to be a metal pipe and struck the victim in the head with it before getting back in his car and fleeing the scene. The victim required medical treatment for his injury. This incident is under investigation. (SFPD Case No. 180237466)

Shooting – Girard / Wayland – 3/30/18, 11:18 pm

Officers responded to a call of shots fired and began searching the area. They located several spent casings. The officers secured the crime scene, preserved evidence and obtained witness statements. Another unit responded to SFGH and located a 27 year old victim of a non-life-threatening gunshot wound, who had admitted himself for treatment. The victim was uncooperative with the officers’ investigation that night, though they were able to determine from him that he had been on **San Bruno** when he was shot. This incident is under investigation. (SFPD Case No. 180237808)

Shots Fired – 700 block Earl – 3/31/18, 4:10 am

Officers responded to a Shot-Spotter activation and located multiple spent casings in the street. They searched the area for possible victims and damage but were unable to locate any that morning. No injuries were reported as a result of this incident, which is under investigation. (SFPD Case No. 180238163)

Aggravated Assault – Oakdale / Griffith – 3/31/18, 5:08 am

Officers responded to a call of an assault. They met with the 41 year old victim who told the officers that he had been assaulted by his adult daughter's friend. He stated that he and the suspect had an argument which culminated with the suspect striking the victim twice with a baseball bat before fleeing the scene. The suspect was identified to the officers and an arrest warrant is pending in this case. (SFPD Case No. 180238185)

Robbery Attempt Arrest – 700 block Missouri – 3/31/18, 4:00 pm

A suspect in a March 20th attempted robbery that occurred on **19th / Connecticut** was identified by investigators, located and taken into custody. He was booked on attempted robbery charges. In the original incident, a 66 year old victim noticed a vehicle that matched the description of a car that had been seen casing vehicles in the area on multiple occasions. The victim watched as the suspect, who had been driving the car, began looking into window of a parked and unattended vehicle. The victim used got his phone out to take a picture of the suspect. The suspect noticed him, ran up and attempted to take the phone away. The victim and the suspect struggled and the suspect threw the victim to the ground. The suspect then got into his car and drove off. The vehicle was located later that day on the **100 block of Dakota** and was towed. (SFPD Case No. 180209142)

Auto Theft Arrest– Rankin / Kirkwood – 4/01/18, 11:20 am

Officers conducted a routine record check of a vehicle that had pulled into a parking space and discovered that the car had been reported as stolen. They detained the suspect as he was getting out of the car and determined that he had outstanding warrants for his arrest with bail amounts totaling \$50,000. He was taken into custody and booked. (SFPD Case No. 180241081)

Firearm Arrest – Indiana / Cesar Chavez – 4/01/18, 2:34 pm

Officers responded to a call of a suspect brandishing a firearm on Geneva who had driven from the scene. The officers located the suspect at **Bayshore and Leland**, driving towards the freeway onramp. The suspect vehicle got onto the freeway, failing to yield to the unit behind it. The suspect took the Cesar Chavez exit and finally pulled over at **Cesar Chavez and Indiana**. The suspect was taken into custody and the **9mm handgun** was recovered from the car along with narcotics. The suspect was booked on

weapons, narcotics, and open container in a vehicle charges. (SFPD Case No. 180241815)

Aggravated Assault w/ Car Arrest– 900 block Innes – 4/02/18, 6:40 pm

Officers responded to a call of a hit and run and located two victims, ages 21 and 39, at the scene with scrapes and abrasions to their arms and legs. The victims reported that they had arranged to meet with the suspect and her friends in order to have a fight over some ongoing disputes. The fight had taken place and the suspect left. While the victims were gathering their things from the street, the suspect came back to the scene in her vehicle. She revved the engine and drove past the victims so closely that one of the victims was struck in the leg with the car as the other fell to the ground to get out of the way. The suspect was identified to the officers who began a search for her and the vehicle. She was located with several passengers in her car at **Ingalls and Quesada**. She was positively identified and arrested. The suspect was booked on two counts of aggravated assault as well as for driving with no license. (SFPD Case No. 180244847)

Hit & Run Arrest – Griffith / Gilman – 4/02/18, 10:08 pm

Officers patrolling the area saw a vehicle driving toward them with only one functioning headlight and made a U-turn to position themselves behind the car. Before they could even activate the light-bar on the radio car to make a traffic stop, the suspect vehicle accelerated to a high rate of speed and passed multiple cars as the driver fled. The suspect ran multiple stop signs as the officers gave pursuit. The vehicle continued driving in a manner that indicated wanton disregard for other drivers so the officers disengaged in the interest of public safety as the suspect vehicle continued onto **Ingerson towards Bill Walsh Way** where he crashed into a fence, destroying the chain fencing and poles. The officers drove to the area and attempted to stop the suspect as he got out and fled on foot, ignoring their commands. The officers chased him on foot through a playground and into a grassy area where he was ultimately overtaken and captured. The suspect was arrested and booked on hit and run, multiple traffic violations, and resisting arrest. (SFPD Case No. 180245243)

Firearm Arrest– 900 block Connecticut – 4/03/18, 2:30 pm

Officers patrolling in the area of the Potrero Hill Housing Development spotted a suspect, who they recognized as being wanted on a no bail probation violation warrant, standing next to his car. He was taken into custody without incident and the officers conducted a probation search of his vehicle. They located a face mask, gloves, and a scarf in the car as well as a **loaded .40 caliber semi-automatic pistol** under the driver's seat. The suspect was booked on firearm violations as well as his warrant. (SFPD Case No. 180246752)

Shots Fired, Recovered Firearm– unit block of Garlington – 4/04/18, 12:00 am

Officers responded to a Shot-Spotter activation and two subjects in the street. As the officers approached, the subjects walked over to a car that had another person seated inside. One subject got in the vehicle, as the other began walking away and attempting to conceal himself. All three were detained. The officers located a spent .380 caliber casing in the street. A further search revealed the **.380 caliber handgun** lying in some ivy nearby. All three suspects were identified and tested for gunshot residue before being released pending further investigation. (SFPD Case No. 180248087)

Suspicious Activity Defined

Suspicious activity is any observed behavior that could indicate a crime-related incident had been committed, or about to be committed.

Examples:

- An individual peering into vehicles or trying door handles, appearing to trying to locate any valuables
- An individual checking front doors of residences, or attempting to locate unattended packages, or following delivery trucks to see where packages are being dropped off.

Crime Defined

Robbery- The taking of property from another by use of force or fear.

Assault- The unlawful attempt, coupled with present ability, to commit a violent

Community Policing Defined

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the community.

- **Homeless Outreach and outreach to Drug Users:** Bayview Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support
- **Foot Patrols:** Bayview Station has beat officers assigned to the 3rd St. corridor, 18th St., and San Bruno Avenue.

injury on another person. *Assault* is when a person swings their arm and *Battery* is when that arm makes contact with another.

Misdemeanor Battery- Any willful and unlawful touching of another

Felony Battery- The use of force or violence upon the person of another that causes serious bodily injury.

Aggravated Assault- Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

Burglary- The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft- Theft committed when the value of the money, labor, or property taken exceeds \$950

Petty Theft- Theft where the value of property taken is less than \$950

Monthly Community Relations

Meetings: Community Meetings are held continuously on the first Tuesday of each month. Officers also attend meetings with merchant groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving

- **Email Updates:** Bayview Station sends out weekly newsletter updates to district residents that outline crime trends, upcoming community events, crime prevention tips, and contact information.

Types of Crime Reports That Can Be Filed Online:

- **Harassing Phone Calls:** When you are experiencing annoying calls - with no known suspects; for example, hang-ups or heavy breathing.
- **Lost Property:** When property has disappeared and not stolen. If you think it could have been taken but you have no idea by who, you may enter the report online.
- **Theft:** When property is stolen but there has been no illegal entry or contact by the thief.
- **Vandalism/Graffiti:** The act of changing, modifying or defacing public or private property, including graffiti.
- **Vehicle Burglary:** When property was stolen from a vehicle.
- **Vehicle Tampering:** Tampering with a motor vehicle, including vandalism/graffiti of the vehicle.

Calling the Police:

Dispatchers ask questions in a particular order for a reason. It is best to stay calm and answer all questions to the best of your ability.

Complaint: **Location, Hazards (ie. weapons at scene), Victim info (sex, age, condition)**

Suspect Description: **Gender, Race, Age, Clothing, distinguishing features**

Vehicle Description: **Color, Make, Model, License Plate, distinguishing features**

Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on April 4th, 5th, 12th, 17th, 24th and 26th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.



Dispose of Unwanted and Expired Medication at Bayview Station

There is a new secured bin at Bayview Station where you can dispose of unwanted and expired medication at any time of the day or night. The bin will accept any type of

prescription and off the shelf medication except for:

- *Herbal Remedies*
- *Vitamins*
- *Supplements*
- *Cosmetics*
- *Other personal care products*
- *Compressed Cylinders*
- *Aerosols*
- *Inhalers*
- *Medical Devices*
- *Sharps*
- *Illicit drugs*
- *L odine containing medication.*

When disposing the medication, please leave it in the original container with your personal information crossed out or removed. You can also place the medication into a clear plastic zip top baggies. Contact the front desk officer and inform them that you want your medication dispose of. The officer will assist you.

Please note that once an item that had been disposed of inside the bin, we cannot retrieve it. So make sure your ring, cell phone or anything of value is not accidentally disposed of.

With over 2,300 different telephone numbers listed to access local government services, many people did not know what number to dial to reach the appropriate department. Now you can connect to city



services with only two numbers to remember: **911** for emergencies and **3-1-1** for everything else.

Before 311, over 50% of calls to the 911 center were not emergency related. **311** relieves 911 operators from these non-emergency calls. If a catastrophic emergency such as an earthquake occurs, **311** operators will be able to provide accurate information to assist during the recovery. In the unlikely event the 911 facilities becomes inoperative, the **311** call center will function as a back up.
