The Institute of Heartmath, the neuroscientists at the forefront of developing resilience in the systems of the human body that sustain life when in energetic coordination, defines "resilience" as: "The capacity to prepare for, adapt to, and recover from stress, adversity, or challenge." This definition broadens the lens in which we view resilience. specifically that we can invest our energy, time, willingness, and commitment now, so that we are all more prepared today than we were yesterday when the unthinkable happens. Ingleside Station is working hard to be resilience partners with all of our neighbors and neighborhoods and looks forward to promoting NEN's Neighborfest and other initiatives in support of Neighborhood Watch, NERT, ALERT, and other community-building programs already in progress.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city
 agencies to provide outreach and assistance to rehabilitate those who are dependent on
 illegal drugs and outreach to homeless individuals to connect them with resources and
 support.
- <u>Foot Patrols</u>: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously.
 Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are "In progress" crimes, which demand an immediate call to 9-1-1:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or

Crime Definition

Robbery - Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

A motorist, possibly harboring the idea that he could be a contestant on "Top Chef", instead ended up enjoying the culinary delights at the County Jail. It all started when Ingleside officers Burke and Downs pulled over a minivan with a non-functioning light. He was unlicensed because he had been convicted before of driving without a license. A search of his car revealed an authentic looking handgun that turned out to be BB gun. He also had an open beer container. But the real find was in the back seat, a large gallon zip lock bag with white powder. The suspect said he was a cook at the Academy of Art and the white powder was flour, paprika, and other secret ingredients used to cook fried chicken. Burke and Downs suspected the white powder was better suited for cooking brain cells. They took the powder to Ingleside Station and their suspicions were confirmed after testing the substance. A report of a man by the Mt. Davidson Cross, acting strangely, prompted dispatch to send Ingleside officer Leong to investigate. The description matched an assault suspect from an incident last April. Leong went to the area near the Cross, found the suspect, and tried to detain him. Three observant Ingleside officers, Archilla, Carew, and Casey spotted one of two men wanted for a burglary that occurred only a few days before described below. He was standing outside a restaurant with a companion.

A business was broken into overnight with suspects taking valuable property and money. Ingleside Officers Lee, Demkowski, and Smith traveled to a bar where surveillance video from the early morning hours showed two suspects removing gaming equipment, cash, and other property from the back door. The officers discovered one suspect entered the bar by removing security bars from a bathroom window and entering the bar. Surveillance video shows another suspect who may be known by the bar owner. A not-so-veiled threat led to the arrest of a student who was an unregistered sex offender. Officer Chiang detained the suspect and ran a computer check that revealed he was a registered sex offender in San Diego. However, he did not register with City College officials as required by law. A man walking home was suddenly confronted by two unknown men who demanded to know where he was from. When the victim didn't respond in a way to please the two suspects, they proceeded to attack him by kicking him in the stomach. The victim told Ingleside officers Jensen and Clayton that he ran away down London Street and fell to the ground during his escape. The officers summoned medical assistance who transported the victim to St. Luke's Hospital for treatment. Report number: 180363613

A frightening experience for a woman and her five year old son. The victim told Ingleside officers Chiang and Cornejo-Rodriquez she woke up in the morning and opened up her bedroom door and saw an unknown masked man standing in her living room holding her purse. Ingleside officers arrested a suspect who was wanted in a particularly brutal robbery that occurred on March 31st of this year. Here was the original description of the crime.

10:05am 200 Blk Crescent Robbery

Two sisters on their way to pick up a family member from karate class were brutally attacked inside St. Mary's Park. Officers Tiffer and Chang responded to the call and located the two victims, both bleeding profusely from their face and head. The one sister told the officers that they arrived at St. Mary's Park to pick up her sister's son who was attending karate class. While they walked into the park, they were attacked from behind by one male suspect and one female suspect. The male suspect grabbed a cell phone and then tried to take a backpack, but one of the sisters instinctively tried to hold on. Both victims were then pushed to the ground and were assaulted with a barrage of punches and kicks from both suspects. After losing possession of the backpack, the suspects fled further into the park where they disappeared. Two witnesses in the park heard the commotion and provided the officers with further information and description of both suspects. Officers Mullins and Garza followed the escape trail and were able to locate a wallet and a cell phone case. Both sisters were taken to San Francisco General Hospital for treatment. Investigators discovered a suspect in the crime resided in a home on the 900 block of Ellsworth. On this date, a Superior Court Judge issued a search warrant and Robbery Investigator Sgt. Hurley along with Sergeant's Do, Boes, Keeve, Sullivan, arrested one suspect and found bullets, a 9mm Ruger pistol, magazine clips, and other items possibly related to the robbery. 5:45pm 1500 Blk. Hampshire Malicious Mischief Vandalism


A minor traffic dispute led to one of the drivers having her car vandalized. 

Robbery Apr 1, 2018 to Apr 31, 2018 24 Incidents





DUI Saturation Patrols This Friday

San Francisco Police Department's Traffic Unit will be conducting DUI saturation patrols this Friday, May 25, 2018, between the hours of 7:00 P.M. and 3:00 A.M. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized DUI checkpoints and proactive DUI patrols are conducted routinely.

Officers will be looking for signs of alcohol and/or drug impairment by checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving. Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, other expenses that can exceed \$10,000, not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to the San Francisco Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to 'Report Drunk Drivers – Call 9-1-1'.

Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on May 8th, 15th, 18th, 24th and 30th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.



Auto Burglary Investigation Leads to an Officer Involved Shooting

On May 11, 2018 at approximately 12:59 AM, uniformed San Francisco Police officers in a marked police car were investigating an auto burglary near Steiner Street and Geary Boulevard. One suspect was detained at that location and the second suspect fled on foot to the area of O'Farrell and Webster Streets where he entered a parked vehicle. The suspect fled in the vehicle, a white Hyundai sedan. On the 1500 block of O'Farrell Street a series of events occurred including collisions between the suspect vehicle and two marked SFPD radio cars and an officer involved shooting.

The suspect vehicle fled the scene and was pursued to the area of Polk and McAllister Streets where it stopped inside Civic Center Plaza. The suspect driver was taken into custody.

No one was struck by gunfire in this incident. The suspect driver was transported to the hospital with non-life threatening injuries. An officer that was injured in the O'Farrell Street incident was treated and released at the scene.

This is an active and ongoing investigation in the early stages. Separate investigations are being conducted by the San Francisco Police Homicide Detail, the SFPD Internal Affairs Division, the San Francisco District Attorney's Office Independent Investigations Bureau and the Department of Police Accountability.

Notes Used During Presentation at the May 21st, 2018 Town Hall to Address the May 11th 2018 Officer Involved Shooting

Synopsis:

May 11, 2018 at approximately 0057 Hrs.

- Two uniformed officers in a marked police vehicle were on patrol in the area of Steiner Street and Geary Boulevard.
- The officers heard an audible vehicle alarm and upon investigating further observed broken glass on the sidewalk and two individuals walking away from a parked vehicle with a shattered window.
- The officers attempted to detain the two individuals who were later identified as 21 year-old Antioch resident, Hershel Hale and 23 year-old Brentwood resident Maurice Jones.
- Jones was detained at the scene by one officer while Hale fled from the scene and was pursued on foot by the second officer.
- The foot pursuit continued for approximately four blocks to the area of Webster Street and O'Farrell Street.
- At that location, Hale entered a parked vehicle, a Hyundai Sonata, started the vehicle and attempted to flee. The officer ordered Hale out of the vehicle but Hale did not comply.
- Hale then drove the vehicle forward from its parked position, striking the rear of a parked car before exiting the parking spot.
- As Hale's vehicle was exiting its parking spot, a second marked SFPD vehicle arrived with two uniformed officers. The driver of the police vehicle stopped police vehicle and the passenger officer exited out the passenger door while the driver remained inside.
- Hale then drove his vehicle towards the stopped police vehicle, striking the right front of the police vehicle.

- Hale then drove his vehicle past the marked police vehicle and in the direction of where the passenger in the police vehicle was now standing.
- That officer then retreated to a safe position to avoid being hit by Hale's vehicle.
- While that officer was moving to a safe position the initial responding officer involved in the foot chase discharged his department firearm at Hale.
- Hale continued to drive his vehicle and at the intersection of Webster Street and O'Farrell Street his vehicle struck the front end of a marked police SUV which was arriving at the intersection.
- Hale then continued to flee in his vehicle and a vehicle pursuit occurred involving Hale's vehicle and the marked police SUV.
- The pursuit ended at Civic Center Plaza where Hale's vehicle jumped the curb and stopped.
- Hale exited his vehicle and was then taken into custody.

Additional Information:

- No one was struck by gunfire during the incident.
- Hale was treated for non-life threatening injuries at Zuckerberg San Francisco General Hospital and then released.
- One officer was evaluated for an injury at the scene of the collisions and officer involved shooting and was released.

Evidence:

 Preliminary evidence indicates that the officer fired two rounds from his department issued weapon.

Video:

- The officer who discharged his firearm did not have his Body Worn Camera activated.
- There is no Body Worn Camera footage that captures the shooting.
- The Body Worn Camera of the officer driving the marked SUV captured the collision, the vehicle pursuit, and the arrest of Hale.
- The body worn camera of the passenger officer in the SUV captured the collision and Hale fleeing in the vehicle he was driving.





San Francisco Police Make Arrest in Cold Case Homicides

On December 9, 1999 at approximately 7:00 PM, San Francisco Police responded to an incident in an apartment building on the 400 block of Bush Street. Former University of Nevada, Las Vegas (UNLV) swimmer Kameron Sengthavy, a 25 year-old male, was found deceased from apparent stab wounds.

On June 1, 2000 at approximately 7:00 AM SFPD officers responded to a gas station at Washington and Van Ness Streets where the body of a gas station attendant, Thomas Lee, a 60 year-old San Francisco resident was found shot by an unknown assailant.

Investigators from the SFPD Homicide Detail conducted investigations of these crimes. After exhausting all leads, these investigations were assigned to the Department's Cold Case Unit.

In early 2018, investigators from the SFPD Homicide Detail's Cold Case Unit developed information that led to the identity of the suspect in these two homicides. The suspect was determined to be a Donovan Ray Lacy, a 38 year-old male.

Lacy is currently serving time in a Florida prison for several bank robberies he committed in that state. Lacy, however, had previously lived in the Bay Area and was brought back to Marin County to stand trial for several bank robberies that occurred in 2012 and 2013. In January of 2014, Lacy was convicted on the Marin County bank robbery charges and was sentenced to 105 years in prison. Following his sentencing in Marin County, Lacy was transported back to Florida. A booking photo of Lacy from Marin County Sheriff's Office accompanies this news release.

SFPD investigators gathered evidence and developed probable cause to charge Lacy with the murders of Sengthavy and Lee. An arrest warrant has been issued charging Lacy with two counts of homicide. Lacy is expected to be extradited to San Francisco to stand trial for the murders.

Upon conclusion of the San Francisco murder trials, Lacy is expected to return to Florida to finish out his nine-year sentence for bank robbery. He would then be transported back to Marin County and serve out his 105-year sentence for the 2012 and 2013 bank robbery convictions.

While an arrest has been made in these cases, they remain open investigations. Anyone with information on the murder of Kameron Sengthavy or Thomas Lee is asked to contact Inspector Dan Cunningham of the SFPD Homicide Detail at (415) 553-9515. The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- 2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- 3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
