This definition broadens the lens in which we view resilience. specifically that we can invest our energy, time, willingness, and commitment now, so that we are all more prepared today than we were yesterday when the unthinkable happens. Ingleside Station is working hard to be resilience partners with all of our neighbors and neighborhoods and looks forward to promoting NEN's Neighborfest and other initiatives in support of Neighborhood Watch, NERT, ALERT, and other community-building programs already in progress.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city
 agencies to provide outreach and assistance to rehabilitate those who are dependent on
 illegal drugs and outreach to homeless individuals to connect them with resources and
 support.
- <u>Foot Patrols</u>: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously.
 Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are "In progress" crimes, which demand an immediate call to 9-1-1:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or

Crime Definition

Robbery - Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

Two men sitting on a park bench were approached by a man they said was acting erratically. One of the men told Ingleside officers Wise and Brown the suspect walked up and grabbed a black bag belonging to him. 
Serious Incidents:



Robbery Apr 1, 2018 to Apr 31, 2018 24 Incidents





Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on May 8th, 15th, 18th, 24th and 30th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.



San Francisco Police Department Mourns the Passing of Former Police Commission President Julius Turman

The San Francisco Police Department today mourns the passing of former Police Commission President Julius Turman. A distinguished labor and employment law attorney and former assistant U.S. Attorney from the District of New Jersey, Commissioner Turman joined the San Francisco Police Commission in 2012, becoming Vice President in 2014 and President in 2016.

Throughout his tenure and in collaboration with community members and department stakeholders, Commissioner Turman and his fellow Commissioners worked diligently to strengthen relations between the SFPD and the public, revise and adopt Department General Orders governing department operations, and implement recommendations by the U.S. Department of Justice COPS Office. He served his final day as Commission President and member on May 4th, 2018.

"Commissioner Turman was a tremendously intelligent and compassionate man who cared deeply about this department," said San Francisco Police Chief William Scott. "He worked to help us increase trust and respect and was relentlessly focused on bringing forth the best practices, policies and procedures to the San Francisco Police Department. We are grateful for his dedication and hard work and we extend our deepest condolences to his family."

"Julius was dedicated to breaking down barriers and building bridges between people," said Police Commission President Thomas Mazzucco. "In the weeks before his passing, he demonstrated strength and fortitude to ensure that the important work of the Police Commission would continue. Auto Burglary Investigation Leads to an Officer Involved Shooting

On May 11, 2018 at approximately 12:59 AM, uniformed San Francisco Police officers in a marked police car were investigating an auto burglary near Steiner Street and Geary Boulevard. One suspect was detained at that location and the second suspect fled on foot to the area of O'Farrell and Webster Streets where he entered a parked vehicle. The suspect fled in the vehicle, a white Hyundai sedan. On the 1500 block of O'Farrell Street a series of events occurred including collisions between the suspect vehicle and two marked SFPD radio cars and an officer involved shooting.

The suspect vehicle fled the scene and was pursued to the area of Polk and McAllister Streets where it stopped inside Civic Center Plaza. The suspect driver was taken into custody.

No one was struck by gunfire in this incident. The suspect driver was transported to the hospital with non-life threatening injuries. An officer that was injured in the O'Farrell Street incident was treated and released at the scene.

This is an active and ongoing investigation in the early stages. Separate investigations are being conducted by the San Francisco Police Homicide Detail, the SFPD Internal Affairs Division, the San Francisco District Attorney's Office Independent Investigations Bureau and the Department of Police Accountability.

Notes Used During Presentation at the May 21st, 2018 Town Hall to Address the May 11th 2018 Officer Involved Shooting

Synopsis:

May 11, 2018 at approximately 0057 Hrs.

- Two uniformed officers in a marked police vehicle were on patrol in the area of Steiner Street and Geary Boulevard.
- The officers heard an audible vehicle alarm and upon investigating further observed broken glass on the sidewalk and two individuals walking away from a parked vehicle with a shattered window.
- The officers attempted to detain the two individuals who were later identified as 21 year-old Antioch resident, Hershel Hale and 23 year-old Brentwood resident Maurice Jones.
- Jones was detained at the scene by one officer while Hale fled from the scene and was pursued on foot by the second officer.
- The foot pursuit continued for approximately four blocks to the area of Webster Street and O'Farrell Street.
- At that location, Hale entered a parked vehicle, a Hyundai Sonata, started the vehicle and attempted to flee. The officer ordered Hale out of the vehicle but Hale did not comply.
- Hale then drove the vehicle forward from its parked position, striking the rear of a parked car before exiting the parking spot.
- As Hale's vehicle was exiting its parking spot, a second marked SFPD vehicle arrived with two uniformed officers. The driver of the police vehicle stopped police vehicle and the passenger officer exited out the passenger door while the driver remained inside.
- Hale then drove his vehicle towards the stopped police vehicle, striking the right front of the police vehicle.

- Hale then drove his vehicle past the marked police vehicle and in the direction of where the passenger in the police vehicle was now standing.
- That officer then retreated to a safe position to avoid being hit by Hale's vehicle.
- While that officer was moving to a safe position the initial responding officer involved in the foot chase discharged his department firearm at Hale.
- Hale continued to drive his vehicle and at the intersection of Webster Street and O'Farrell Street his vehicle struck the front end of a marked police SUV which was arriving at the intersection.
- Hale then continued to flee in his vehicle and a vehicle pursuit occurred involving Hale's vehicle and the marked police SUV.
- The pursuit ended at Civic Center Plaza where Hale's vehicle jumped the curb and stopped.
- Hale exited his vehicle and was then taken into custody.

Additional Information:

- No one was struck by gunfire during the incident.
- Hale was treated for non-life threatening injuries at Zuckerberg San Francisco General Hospital and then released.
- One officer was evaluated for an injury at the scene of the collisions and officer involved shooting and was released.

Evidence:

 Preliminary evidence indicates that the officer fired two rounds from his department issued weapon.

Video:

- The officer who discharged his firearm did not have his Body Worn Camera activated.
- There is no Body Worn Camera footage that captures the shooting.
- The Body Worn Camera of the officer driving the marked SUV captured the collision, the vehicle pursuit, and the arrest of Hale.
- The body worn camera of the passenger officer in the SUV captured the collision and Hale fleeing in the vehicle he was driving.





San Francisco Police Make Arrest in Cold Case Homicides

On December 9, 1999 at approximately 7:00 PM, San Francisco Police responded to an incident in an apartment building on the 400 block of Bush Street. Former University of Nevada, Las Vegas (UNLV) swimmer Kameron Sengthavy, a 25 year-old male, was found deceased from apparent stab wounds.

On June 1, 2000 at approximately 7:00 AM SFPD officers responded to a gas station at Washington and Van Ness Streets where the body of a gas station attendant, Thomas Lee, a 60 year-old San Francisco resident was found shot by an unknown assailant.

Investigators from the SFPD Homicide Detail conducted investigations of these crimes. After exhausting all leads, these investigations were assigned to the Department's Cold Case Unit.

In early 2018, investigators from the SFPD Homicide Detail's Cold Case Unit developed information that led to the identity of the suspect in these two homicides. The suspect was determined to be a Donovan Ray Lacy, a 38 year-old male.

Lacy is currently serving time in a Florida prison for several bank robberies he committed in that state. Lacy, however, had previously lived in the Bay Area and was brought back to Marin County to stand trial for several bank robberies that occurred in 2012 and 2013. In January of 2014, Lacy was convicted on the Marin County bank robbery charges and was sentenced to 105 years in prison. Following his sentencing in Marin County, Lacy was transported back to Florida. A booking photo of Lacy from Marin County Sheriff's Office accompanies this news release.

SFPD investigators gathered evidence and developed probable cause to charge Lacy with the murders of Sengthavy and Lee. An arrest warrant has been issued charging Lacy with two counts of homicide. Lacy is expected to be extradited to San Francisco to stand trial for the murders.

Upon conclusion of the San Francisco murder trials, Lacy is expected to return to Florida to finish out his nine-year sentence for bank robbery. He would then be transported back to Marin County and serve out his 105-year sentence for the 2012 and 2013 bank robbery convictions.

While an arrest has been made in these cases, they remain open investigations. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
