#### **Arrests:**

#### **4:16am 100 Blk. Alemany D.U.I**

A vehicle collision with a pole in the empty Farmers Market parking lot prompted dispatch to send Ingleside Officers Duran and Fogarty to investigate. When they arrived they found the driver of an older Acura sweaty, with droopy eyelids, and slurred speech. There were two other passengers in the car. The driver agreed to a roadside sobriety test which he failed. An alcohol breath analysis showed him on the cusp of legal intoxication. He told the officers that he consumed a small amount of alcohol and was taking a prescription narcotic medication. He agreed to a blood alcohol test and was driven to Mission Station where a phlebotomist administered the exam. The officers believed the combination of alcohol and medication contributed to his inability to drive safely. After the exam his driver's license was confiscated and he was cited for misdemeanor DUI. His car was towed to impound and the case is ongoing waiting for the results of the blood alcohol test. Report number: 180645336

A bookstore customer, waiting in the checkout line, was suddenly passed by the man behind him who exited the store with a basket full of stolen candy. The witness went outside and told Community College Police Officer Allen who, along with other CCP officers chased and then apprehended the suspect a block away. They found stolen candy bars in his pockets and found the shopping basket nearby in some bushes containing more candy bars. ## San Francisco Police Respond to Firearm Related Incident at Balboa High School

On Thursday, August 30, 2018 at approximately 11:15 AM, San Francisco Police responded to Balboa High School regarding a possible gunshot fired in a classroom. The San Francisco Unified School District placed Balboa High School on lockdown and lockout. In an abundance of caution, Leadership High School, Denman Middle School, and San Miguel Early Education School were also placed on lockdown and lockout.

A methodical search of the campus was conducted, resulting in four Balboa High School students being taken into custody. A firearm and spent bullet casing were also recovered. At this time, one student is under investigation for the firearm discharge, with the three other students being investigated as possible accessories after the fact.

One student sustained non-life threatening injuries unrelated to the firearm discharge and was evaluated and released to parents at the scene. No other students were injured in this incident.

The San Francisco Police Department works closely with the San Francisco Unified School District, the San Francisco Fire Department, and the Bureau of Alcohol, Tobacco, Firearms, and Explosives to coordinate responses for these types of incidents. This is an active and ongoing investigation. Anyone with information is asked to call the SFPD Tip Line at (415) 575-4444 or Text a Tip to TIP411 and begin the text message with SFPD. #### What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

#### Pathways to ALERT membership:

- Complete NERT training and receive certification.
   To register for NERT training courses, please visit www.sfgov.org/sfnert. Once NERT Certified, forward a copy of your NERT ID card to the ALERT program at sfpdalert@sfgov.org. After clearing our background check, you are eligible for ALERT training.
- If you are an SFPD Community Police Academy graduate, you are eligible for ALERT training after clearing our background check.

#### San Francisco Police Conduct Missing Person Investigation

In late July, 2018 and during the first week of August, 2018 the San Francisco Police Department was contacted by the family and neighbors of 65 year-old Brian Egg who were concerned that they had not seen or heard from Mr. Egg in some time. On both occasions, officers responded to Mr. Egg's residence on the 200 block of Clara Street, but received no response and saw no suspicious circumstances. On August 7, the San Francisco Police Department began a missing person investigation after a family member of Mr. Egg reported him missing. Officers responded to the location again but were met with no response at the residence.

On August 14, 2018 concerned neighbors of Mr. Egg called 911 to report that a suspicious person was outside Mr. Egg's residence, along with a crime scene cleaning truck. Officers responded to the scene, detained the individual and were able to make entry to the residence. Officers did not locate Mr. Egg but found evidence including cleaning products and suspicious odors in the residence. On August 15, the SFPD Homicide Detail took over the investigation and a search warrant was authorized for Mr. Egg's residence. While searching the location, SFPD investigators found human remains inside a fish tank.

The San Francisco Medical Examiner's Office responded and took control of the human remains. The identity of the person is still pending.

During the course of this investigation, Homicide investigators developed leads that led to the August 16 arrests of two suspects: 39 year-old Lance Silva of San Francisco, and 52 year-old Robert McCaffrey of San Francisco. They were arrested on homicide, fraud, theft, identity theft and elder abuse charges and booked into San Francisco County Jail. These charges were later discharged by the District Attorney's Office pending further investigation. Silva remains in custody at Alameda County Jail for a probation violation.
