Dear President Turman and San Francisco Police Commissioners,

Summary of Complaints Received in April 2017 and Companion Reports

In compliance with San Francisco City Charter section 4.136 and Police Commission Resolution number 97-04, which require the Department of Police Accountability (DPA) to provide the Police Commission with a monthly summary of complaints received including the number and type of complaints filed, attached please find a summary of cases received in April 2017, a Comprehensive Statistical Report, a pending case list, and a "How Complaints Were Received" report for the period January 1, 2017 through April 30, 2017. For comparison purposes, reports for the period January 1, 2016 through April 30, 2016 are also included.

Mediation of Complaints in April 2017

The DPA mediated four (4) cases in April 2017, which was the same number of cases mediated in April 2016. The DPA mediated eight (8) cases from January 1 through April 30, 2017, compared with 19 cases mediated in the same period in 2016.

Chief's Proposed Discipline on DPA Sustained Complaints in April 2017

In April 2017, Chief William Scott proposed discipline in two (2) cases investigated by the DPA and determined by the DPA Director to contain sustainable allegations. The DPA Director's findings and recommended discipline and the Chief's proposed discipline are as follows:

1. Conduct Reflecting Discredit – An officer made inappropriate comments and engaged in inappropriate behavior, in violation of SFPD General Order 2.01,

General Rules of Conduct, and Neglect of Duty for failing to collect traffic stop data.

The DPA Director recommended a written reprimand.

The Chief of Police found insufficient evidence to sustain the Conduct Reflecting Discredit allegation. The Chief of Police imposed a written reprimand and retraining on the officer for the Neglect of Duty allegation.

According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for Class D neglect of duty is a written reprimand for a first offense.

2. Neglect of Duty – An officer failed to comply with Department Bulletin No. 14-059, Traffic Stop Data Collection Program Information.

Based on the officer's disciplinary history, the DPA Director recommended a three-day suspension.

The Chief of Police imposed a written reprimand and retraining on the officer.

According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for Class D neglect of duty is a three-day suspension for a second offense.


